- a. Where the secondary assessment is required, MuslimFest will contact the Applicant(s) with further information as soon as possible.
- b. Secondary assessments may include, but not limited to, further questions for Art Exhibit or Film Festival submissions, or auditions for Rising Talent Applicants. How and when the second assessment will take place is the sole discretion of MuslimFest, which may be after the end of the application period.
- 4. All submissions must be respectful of Islamic teachings and sensitive to moral standards, as determined by MuslimFest's Board of Directors. Submissions must be suitable for viewers of all ages.
- a. Submissions may not depict or suggest, implicitly or explicitly, hate, violence, or sexuality, with the exception of Film Festival submissions.
- b. With respect to the Film Festival submissions, MuslimFest reserves the right to limit the audience and apply an appropriate warning if upon assessment it determines that some content may be deemed violent or sexual in nature, whether explicit or suggested.
- c. No hate of any sort or gratuitous violence or sexuality shall be acceptable.
