1. OVERVIEW TERMS

 - 1. All other services including custom booth displays, WiFi, electricity, materials, shipping, material handling, labor, special furniture, etc., must be ordered separately by the Exhibitor, directly through TriCord Events Services and are not included in the charge for the exhibit space.  - 1. California state law requires that all exhibitors selling merchandise from the floor or taking orders either on a wholesale or retail basis must have a valid California Seller's Permit (temporary or ongoing)

 - 2. IF FOOD SAMPLING:
 - i. Items dispensed are limited to products manufactured, processed or distributed by exhibiting firm.
 - ii. All Items are limited to sample size and must be distributed from exhibit location
 - iii. Beverage samples are limited to a maximum of 2 fluid ounces of product. Food Items are limited to "Bite Size" portions of 1 oz.
 - iv. Exhibiting firm or show management must also obtain a Health Permit from the Health Department. Prices for the temporary food sampling permit range from \$77-\$140 and are due by October 15th, 2019
