- 1. Exhibitor set up time starts Friday, March 20, 2020, from 12:00 PM to 8:00 PM and Saturday, March 21, 2020 from 7:00 AM to 8:30 AM for the event. Exhibitors will not be permitted to set up after the cut off times. All booths must be completely setup for operation by 9:00 AM on event date. VENDORS WILL NOT BE ALLOWED TO SET UP ANYTIME PAST 9AM. Vendor displays MUST remain intact throughout the duration of the event.
- 2. Additional passes can be purchased for \$10.00 (LIMIT 2) preferably prior to the event. BOOTH SHARING IS NOT PERMITTED AT ANY TIME and could result in security escort from the event.
- 3. Exhibitor assumes full liability and risk and holds Natural Hair & Health Expo (NHHEXPO) as well as Visions Beauty Distributors and any affiliates, partners, management and employees harmless against and from any loss or damage as a result of this event, including damage to personal property or guest injury.
