

# Motorcycle Depot Ride, Rally & Show Vendor Rules and Regulations

1. **Advance Payment.** All booth space must be paid for in advance. We cannot guarantee your space until full payment is received. Booth space will be assigned upon payment.
2. **Booth Set up.** Booth and aisle spacing is designed in accordance with local regulations. Please DO NOT rearrange, move, or in any way change the way your booth and or aisle is set up and marked.
3. **No Shows.** Any booths that have not been claimed (i.e. which do not contain vendor merchandise) by start time on event day will revert to the Expo and may be given away or resold. No refunds will be given.
4. **Cancellations.** No refunds or credit will be given on booths cancelled less than 3 weeks before the event or for anyone who is a no show for any reason (including weather). Credit will be given for the next event only if you inform us at least 21 days prior to the event that you will not be coming.
5. **Sales Tax.** Be advised that you are responsible for collecting sales tax on your sales and for being familiar with the tax rules regarding your business.
6. **Food and Drink Sales.** No food or beverage sales that are in direct conflict with those that are provided by the event will be allowed. There are some exceptions for packaged items such as beef jerky. If you plan on selling any food or beverage items at the event it is your responsibility to disclose these items to Expo personnel prior to setup to ensure that they will be allowed.
7. **Subletting of Booth Space.** There will be absolutely NO subletting of booth space (or any portion thereof) without prior approval of Expo management. If you sublet any portion of your booth you are personally responsible for the merchandise and actions of your sublessee.
8. **Prohibited Items.** Colorado Motorcycle Expo retains the right to have any exhibited items it deems to be in poor taste or otherwise inappropriate (in its sole discretion) to be modified or removed. This includes but is not limited to explosives, incendiary devices, pornography, and illegal or offensive items of any kind. Also, no firearms or weapons of any kind are allowed in the event.
9. **Security.** It is the vendor's responsibility to secure all items in your booths. We strongly encourage (but do not require) you to use glass cases for small valuable items that are easy to shoplift.
10. **Insurance.** It is the vendor's responsibility to carry any necessary insurance. You are not covered by any insurance obtained by Colorado Motorcycle Expo or Motorcycle Depot..
11. **Compliance with Laws.** By exhibiting any items at our event, you agree to abide by all local, State, and Federal laws as well as all Expo rules. Safety is our primary concern.
12. **Event Cancellation.** In the event the Event is cancelled by Colorado Motorcycle Expo or Motorcycle Depot, prior to the start date you will be refunded all money paid for your booth space. No refunds will be given for cancellation of the Event for causes beyond the control of Colorado Motorcycle Expo or Motorcycle Depot, including but limited to, weather, act of God such as, but not limited to, fires, explosions, earthquakes, drought, tidal waves and floods, acts or threats of terrorism or criminal activity.
13. **WAIVER OF CLAIMS.** IN CONSIDERATION OF BEING GRANTED THE RIGHT TO PARTICIPATE IN THE COLORADO MOTORCYCLE EXPO, AND AS A CONDITION THERETO, YOU HEREBY EXPRESSLY WAIVE ALL CLAIMS OF ANY KIND AGAINST THE COLORADO MOTORCYCLE EXPO AND MOTORCYCLE DEPOT, ITS VENDORS AND THEIR RESPECTIVE OFFICERS, MEMBERS, EMPLOYEES, CONTRACTORS AND AGENTS FOR ANY MISHAP, INJURY OR LOSS OCCURRING AT THE SHOW UNLESS SUCH LOSS IS AS A DIRECT AND SOLE RESULT OF THE GROSS NEGLIGENCE OR WILLFUL MISCONDUCT OF COLORADO MOTORCYCLE EXPO EMPLOYEES. YOU UNDERSTAND THAT SAFEKEEPING OF ALL VALUABLES WHICH YOU BRING TO THE SHOW IS YOUR SOLE RESPONSIBILITY.
14. **INDEMNIFICATION.** IN CONSIDERATION OF BEING GRANTED THE RIGHT TO PARTICIPATE IN THE MOTORCYCLE DEPOT RIDE, RALLY & SHOW, AND AS A CONDITION THERETO, YOU HEREBY AGREE TO INDEMNIFY, DEFEND, AND HOLD HARMLESS COLORADO MOTORCYCLE EXPO, AND MOTORCYCLE DEPOT, INCLUDING THEIR RESPECTIVE MEMBERS, EMPLOYEES CONTRACTORS AND AGENTS, FOR ANY LOSS, COSTS, OR EXPENSES RELATING TO YOUR ACTIVITIES AT THE EXPO OR ANY THIRD-PARTY CLAIMS THAT MAY ARISE THEREFROM. YOU WILL ALSO BE RESPONSIBLE FOR ALL MISHAPS, INJURIES OR LOSSES DUE TO THE ACTIONS OF ANY PERSON(S) SUB-LEASING PART OF YOUR TABLES OR OTHERWISE ASSISTING YOU.
15. **Failure to Follow Rules.** Failure to follow these rules may lead to eviction from the event. In such an event no refunds will be given.
16. **COVID.** All vendors are required to abide by Adams County Health Department regulations at the time of the event..
17. **Modifications/Additional Rules & Regulations.** These rules are subject to change from time to time and you may be given additional instructions on site to help ensure a safe, enjoyable, and profitable event for all!
